

Coffee-mate Holiday Kitchen Sweepstakes

Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: Coffee-mate Holiday Kitchen Sweepstakes (the "Promotion") is open only to legal residents of the fifty (50) United States (including District of Columbia) who are at least eighteen (18) years old at the time of entry. Employees of Nestlé USA, Inc., Hip Digital Inc., Martha Stewart Living Omnimedia, Inc., MetaVision Media, LLC, Publicis Inc. d/b/a Kaplan Thaler, Interfuse Communications, Inc., Zocalo Group, LLC, HelloWorld, Inc., and their parent and affiliate companies, suppliers as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. The Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's and Administrator's decisions, which are final and binding in all matters related to the Promotion. 3. Timing: The Promotion begins on September 15, 2014 at 12:00 a.m. Eastern Time ("ET") and ends on December 31, 2014 at 11:59 p.m. ET (the "Promotion Period"). Administrator's computer is the official time-keeping device for this Promotion.

4. How to Enter:

a. Purchase a COFFEE-MATE Product: During the Promotion Period, purchase a COFFEE-MATE product and take a picture of the receipt. Receipt must show the COFFEE-MATE® purchase, date of purchase, store name, store address. Then, visit www.holidayentry.coffee-mate.com (the "Website") and complete and submit the registration form including a valid home address (P.O. Boxes are not permitted) and upload the image of your receipt. The image must be 3MB or smaller and in .jpg format. For each COFFEE-MATE product purchased, you will receive one (1) Sweepstakes entry and one (1) Instant Win Game play for that day, up to a maximum of ten (10) COFFEE-MATE products per receipt and three (3) receipts per day. Entrant must use each Game play earned at the time he/she uploads the receipt and cannot save the Instant Win Game plays for any future logins.

b. Free Method of Entry: You will need a code ("Code") to enter without making a purchase. You may obtain a Code as described below.

i. Mail-in Method (available September 15, 2014 through December 17, 2014): Send a Code request with your name, address, day and evening phone numbers, email address, and date of birth on a 3" x 5" piece of paper and mail it in an envelope with proper postage to "Coffee-mate: Holiday Kitchen Sweepstakes," to Department: 813857, PO Box: 5812, Kalamazoo MI 49003-5812 ("Code Request"). Within two (2) business days of receiving your request, Sponsor will send thirty (30) Codes to the email address identified on the request. Limit: One (1) Code Request per envelope. All mail-in requests must be handwritten and must be postmarked by December 17, 2014 and received by December 24, 2014. All requests become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due requests, which will not be honored.

ii. Online Method (available only from December 18, 2014 through December 31, 2014): Use R3HV7FXGT6TY as your Code. This Code will only be accepted from December 18, 2014 through December 31, 2014. Limit: Entrants can use this code thirty (30) times per day from December 18, 2014 through December 31, 2014.

Once you have a Code, visit the Website, click on the "Don't have a receipt?" link and follow the

links and instructions to complete and submit the registration form including a valid home address (P.O. Boxes are not permitted) and your Code. You will receive one (1) entry into the Sweepstakes and advance to the Instant Win Game page and receive one (1) Instant Win Game play for that day for valid submission. Limit thirty (30) game plays per person, per day.

Once on the Instant Win Game page, follow the links and instructions to play the Instant Win Game. The Instant Win Game results will be instantly displayed. Potential winners of the Instant Win Game will be provided directions for validation and redemption of prize. All potential winners are subject to verification before any prize will be awarded. Administrator is responsible for the functionality of the Instant Win Game.

Limit: Each entrant may enter the Sweepstakes thirty (30) times per day during the Promotion Period. Multiple entrants are not permitted to share the same email address. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible or misdirected registrations, which will be disqualified. In the event of a dispute as to any registration or play, the authorized account holder of the email address used to register will be deemed to be the entrant or player. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winners may be required to show proof of being the authorized account holder.

5. Sweepstakes/Instant Win Game: Administrator is an independent judging organization whose decisions as to the administration and operation of the Promotion and the selection of potential winners are final and binding in all matters related to the Promotion.
