Official Rules

NO PURCHASE NECESSARY. PURCHASE WILL NOT IMPROVE CHANCES OF WINNING.

ELIGIBILITY: The Sweet Summer Downloads Sweepstakes (“Sweepstakes”) begins on May 1, 2015 at 12:00 a.m. eastern time (“ET”) and ends on July 31, 2015 at 11:59 p.m. ET (“Promotion Period”). The Sweepstakes is open to legal residents of the 50 United States, the District of Columbia, and Puerto Rico that are at least 13 years old. Void where prohibited. Employees of Perfetti Van Melle USA, Inc., Erlanger, KY 41018-0190 (“Sponsor”), and its respective parent companies, subsidiaries, affiliates, advertising agencies, public relations agencies, prize suppliers, including any vendors providing services in connection with this Sweepstakes (collectively, the “Sponsor Affiliates”), and employees, agents, directors, officers (including members of their immediate family – i.e., spouse, mother, father, in-laws, grandmother, grandfather, brother, sister, children and grandchildren – or same household) of Sponsor or any Sponsor Affiliates are not eligible to participate.

Upon completing the two steps listed above and submitting your Qualifying receipt, you will receive one (1) entry into the Sweepstakes.

- 2) *Without a Purchase.* During the Promotion Period, visit <http://sweeter.hiprewards.com/Receipt/Index> and follow the links and instructions to complete and submit the registration form, including providing your email address, and your first and last name. (You will not be required to provide the name of a retail store where Sponsor’s products may have been purchased.) Then, follow the links and instructions to enter without a receipt. Upon completing the steps listed above, you will receive one (1) entry into the Sweepstakes.

Limit one (1) entry per person, per day regardless of method of entry.
